#### Summer Camp Waiver and Release of Liability

I hereby give my permission as Parent/Guardian for my child \_\_\_\_\_\_\_ to participate in the Summer Youth Day Camp at Frog Hollow Nature Area, property of Schuylkill County Parks and Recreation (Parks), and sponsored by Schuylkill County Conservancy – Friends of Frog Hollow (SCC).

I acknowledge, understand and appreciate that as part of my Child's participation in the Camp there are dangers, hazards and inherent risks to which my Child may be exposed, including the risk of serious physical injury, temporary or permanent disability, and death, as well as economic and property loss. I further realize that participating in the Camp may involve risks and dangers, both known and unknown, and have elected to allow my Child to take part in the Camp.

I understand that outdoor activities may occur in the hot sun and in the rain. I agree to see that my child is appropriately attired for camp activities, and to provide insect repellant and sunscreen for my child to use at camp. I will not expect the SCC camp staff to provide these items. I give my permission for Frog Hollow camp leaders to apply or assist with the application of the repellant and sunscreen I provide.

I understand and acknowledge that my failure to disclose relevant information may result in harm to my child and/or others during this Camp. By signing my name, I represent and warrant that my child's mental, physical or medical condition enables him/her to participate in the Camp without any special accommodation.

I understand that the Schuylkill County Conservancy camp staff may, in its sole discretion, dismiss any camp participant for inappropriate, disrespectful, or dangerous behavior at any time. In this event, I understand that I will not receive a refund of camp fees for unattended days. If my child breaks or damages any property as a result of their direct or indirect behavior, I hereby agree to pay for its repair or replacement.

I understand that Schuylkill County Conservancy and Schuylkill County Parks recommends consulting with a physician prior to allowing our child to participate in this Camp and if I am uncertain about any pre-existing medical conditions, it is my responsibility to consult with my Child's physician prior to my Child participating in this Camp.

In the event of illness, injury, and/or accident, I authorize the camp instructor or any SCC camp staff to act on my behalf. They may approve any and all non-emergency or emergency treatment and are authorized to sign any and all medical release or required form(s) on my behalf. In the event of an emergency, I understand that I will be notified of the situation as soon as practicable. I agree to pay any necessary expenses incurred in the medical treatment of my child, including, but not limited to all transportation costs to and from a medical facility, and/or to a medical facility of choice. I understand that as a parent/guardian, my insurance is primary.

In consideration of my application and permitting my child to participate in this activity, I hereby:

WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the Schuylkill County Conservancy and Schuylkill County Parks and Recreation, its trustees, officers, employees, camp counselors, volunteers, entities or other persons released, for my child's death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them;

INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Schuylkill County Conservancy, its trustees, officers, employees, volunteers, or other entities or persons released from any and all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

I understand that while participating in this activity, my child may be photographed. I agree to allow their photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. The Schuylkill County Conservancy, its trustees, directors, officers, and all its employees, acting officially or otherwise are hereby released from any and all claims, demands, actions, or causes of action on account of any injury to my child that may occur. This release binds my heirs, executors, administrators, and/or assigns.

# FROG HOLLOW NATURE AREA SUMMER YOUTH DAY CAMP

#### Important Summer Camp Information

<u>Camp Location</u>: Frog Hollow Nature Area is just outside of Friedensburg, PA by taking Church Road and then the cutoff to Stone Mountain Road for just over one mile. GPS locator should use: 170 Stone Mountain Road, Schuylkill Haven, PA. Dates are June 16, 17 and 18, 2025 from 9:00-12:00 noon.

<u>Check-in and Pick-up</u>: Utilize the parking lot off Schuylkill Mountain Road designated for Frog Hollow Nature Area. **Drop-off** between 8:50 and **9:00 am** by checking in with the attendant. If a party other than the drop-off person is to pick-up the child, please leave the name and phone contact number.

**Pick-up** is at **12:00 noon**. Drive carefully when entering the parking area. Inform a park's volunteer of your arrival and child to transport.

<u>Program Activities</u>: Programs each day will vary and utilize the grounds of Frog Hollow Nature Area. It may not be possible to see the activity areas being used. In case of inclement weather, camp will be held and located under the Pavilion some distance from the parking lot.

Each day will include a theme focus, walk in the woods, exploring that theme within Frog Hollow, making a creative item to take home, a mid-day snack. The themes are plants, animals, and weather and water.

<u>Dress and Packing:</u> Dress for the weather to include outer wear and footwear. Frog Hollow is a wetland and paths are uneven and not always dry. Wear shoes that can get dirty and wet. Some activities will engage with the Upper Little Swatara Creek. Extra clothes to include a sweater or jacket should be accompanied with a container for carrying, such as a bag or backpack.

<u>Health and Safety</u>: All precautions will be taken to ensure the safety of your child. Minor injuries will be addressed by staff with a phone call to you. More serious injury or health situation will result in calling an ambulance in addition to trying to reach the emergency contact. Authorization for emergency medical care intervention at a facility will be assumed only if the situation warrants. Any special health care needs should be shared with camp staff.

Volunteer staff have current child clearances.

Insurance: In the event of an accident or injury, the insurance of the camper's legal guardian(s) is primary.

<u>Lost and Found</u>: Lost and Found items will be kept for two weeks after the camp. Frog Hollow Nature Area nor volunteers are responsible for lost or broken items. Report missing items as soon as possible. Frog Hollow is open to the public and retrieving lost items cannot be assured. Check with your child each day for personal items.

<u>Payment:</u> Cost of \$15 is due at the time of the Registration Application. Registrations are being received from Aril 1 to May 31, 2024. After the May 31 date, cancellation and refunds will no longer be possible.

<u>Nutritional Snacks</u>: Mid-morning snacks will be offered in the form of water/juice, cereal bar and/or fruit. If your child prefers his/her own snacks from home, they should accompany the child in a water secure container. Inform camp workers of this choice. Food allergies such as peanut butter, gluten-free or food dyes should be shared.

<u>Contact with Youth Camper</u>: Youth campers will be engaged throughout the camp time. Camp staff will be attentive to any difficulty that may arise. It is desired that youth campers not have cell phones with them. Contact should be made with camp staff.
